



TomTom share buyback periodic update, 22 – 26 February 2021

Amsterdam, The Netherlands, 2 March 2021, 07:30 CEST - TomTom ([TOM2](#)), today announced that it has repurchased 459,250 ordinary TomTom shares at an average price of €7.70 per share in the period from 22 February 2021 up to and including 26 February 2021. The aggregate consideration of this repurchase was €3.5 million. These repurchases were made as part of the company's €50 million share buyback program initially [announced](#) on 2 March 2020 and [resumed](#) on 15 February 2021.

The total number of shares repurchased since the initial announcement of the program up to and including 26 February 2021 is 3,180,355 shares for a total aggregate consideration of €23.0 million.

TomTom will use the shares to cover its commitments arising from its long-term employee incentive plans. Details of the share buyback transactions can be found on the company's [website](#).
